**Sub:- Display of Mandatory Public Disclosure at Home Page in school's website under prominent icon labelled as "Mandatory Public Disclosure" for easy access by the member of public to ensure transparency (reference Cir. No. 03/2021 dated 05.03.2021)-Reg**

Dear Principal,

This is in continuation to CBSE Circular No. 03/2021 dated 05.03.2021(copy enclosed) issued by Secretary, CBSE wherein it has been reiterated that as per clause 2.4.9 of Affiliation Bye Laws 2018 "Every affiliated school will develop their own website containing comprehensive information such as Affiliation status, details of infrastructure, details of teachers including qualifications, number of students, address-postal and email, telephone nos., copies of transfer certificates issued, etc. as may be directed by the Board from time to time. The website so created should also have information with regard to fees charged. Mandatory Public Disclosure as per the format available at Appendix-IX shall be uploaded at prominent place on the website."

2. The above requirement was reminded from time to time and the latest reminder issued, vide CBSE Affiliation Circular No. 02/2022 dated 22.02.2022 issued by Secretary CBSE, wherein all the CBSE Affiliated schools were directed to update their OASIS data and for display of Mandatory Public Disclosure at Home Page in school's website in consonance with the directions given as per clause 2.4.9 of Affiliation Bye Laws 2018. In this connection, it has been observed that inspite of clear directions issued from the Board many CBSE affiliated schools are still not updating their school website with Mandatory Public Disclosure, which is in violation of Board's directions and CBSE Affiliation Bye Laws, 2018 and which have been viewed seriously by the Competent Authority of the Board.

3. Therefore, time bound action is required and all affiliated schools under the jurisdiction of Regional Office, Bhubaneswar are directed to submit compliance to Circular No. 02/2022 dated 22.02.2022 on or before 15.03.2022 through the Google Form given below:
